ORDINANCE SERIAL NO. 90-35

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING SECTION 9.08.050 OF THE WASILLA MUNICIPAL CODE, TAXICAB REGULATIONS.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

SECTION I. Classification. This is a code ordinance and shall become a permanent part of the Wasilla Municipal Code.

SECTION II. Purpose. To amend Section 9.08.050 to conform with State insurance requirements.

SECTION III. Amendment. Section 9.08.050 is amended to read as follows:

9.08.050 Insurance Required. A. Before any taxicab permit is issued for any vehicle for hire, the applicant therefor shall furnish one or more [policies or] certificates of insurance [assured by] FROM an insurance company authorized to do business in the State of Alaska. [providing indemnity for the insured in the amounts specified herein and agreeing to pay within the limits of said recovering final judgement creditor other than the employee of the insured recovering final judgement for personal injuries, including death, and damages to property suffered during the applicable year in which the insurance is in effect resulting from the negligent operation, maintenance, or use of the vehicle.]

B. The minimum insurance liability of the applicant as to any one covered public vehicle shall be [on account of injury to or death of any one person in any one accident, \$100,000; on account of any one accident resulting in injury to or death of more than one person, \$300,000; on account of injury to or death of any one person in any one accident caused by an uninsured motorist, \$25,000; on account of any one accident caused by any uninsured motorist resulting in injury to or death of more than one person, \$50,000.] \$100,000 PER PERSON AND \$300,000 PER ACCIDENT FOR BODILY INJURY AND \$50,000 PER ACCIDENT FOR PROPERTY DAMAGE OR \$300,000 COMBINED SINGLE LIMIT OF LIABILITY PER ACCIDENT FOR BODILY INJURY AND PROPERTY DAMAGE LIABILITY. \$100,000 PER PERSON AND \$300,000 PER ACCIDENT FOR BODILY INJURY AND \$25,000 PER ACCIDENT FOR PROPERTY DAMAGE FOR UNINSURED OR UNDERINSURED MOTORISTS COVERAGE, OR \$300,000 COMBINED SINGLE LIMIT OF LIABILITY

PER ACCIDENT FOR UNINSURED OR UNDERINSURED MOTORISTS  
COVERAGE.

C. The [policy or policies] CERTIFICATE(S) of liability insurance shall be approved as to substance by the Clerk and as to form by the City Attorney and filed with the Clerk.


D. Notice of Cancellation or Termination of Insurance. Every such [insurance policy or] certificate shall contain a clause obligating the insurer [or surety] to give the Clerk by registered mail, at least [fifteen] TWENTY (20) days' written notice before the cancellation, expiration, lapse, or other termination of such insurance. A lapse of insurance coverage shall work an automatic suspension of any permit during the period the permittee is without such insurance.

SECTION IV. Effective Date. This ordinance becomes effective January 1, 1991.


