ORDINANCE SERIAL NO. 93-58

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTERS 9.04 (BUSINESS LICENSES) OF THE WASILLA MUNICIPAL CODE.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

SECTION I. Classification. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

SECTION II. **Purpose**. To amend Chapter 9.04 of the Wasilla Municipal Code to move the responsibility from the City Clerks office to the Finance office.

SECTION III. Amendment. Chapter 9.04 and it's underlying ordinances are amended as follows:

SECTION IV. Repeal. Repeal the existing language of section 9.04.050 and replace with the new language for section 9.04.050.

Replace the term City Clerk with Finance Director throughout the entire lapter.

- 9.04.010(A) License Required. For the privilege of engaging in business in the City of Wasilla, a person shall first apply to do so, and pay the license fee provided in Section 9.04.040 of this chapter. A license issued to a firm for a particular line of business covers all its operations in the City of Wasilla in the line of business regardless of the number of its establishments. Effective with calendar year 1994 501c(3)(4) Nonprofit organizations are required to obtain a City of Wasilla Business License and pay the license fee provide in Section 9.04.040 of this chapter.
- 9.04.020(C)Renewal and Duration. Newly established businesses applying for a City Business License after December 1st, each year, will be issued a Business License for the following calendar year.
- 9.04.040 Fee. Effective January 1, 1984, the license fee for each business shall be Twenty-Five Dollars (\$25.00) for the calendar year or any part thereof. Effective January 1, 1994 501c(3)(4) nonprofit organizations will be required to obtain a city of Wasilla Business License at no cost, for the calendar year or any part thereof.

9.04.050 City Clerk- Regulations. The City Clerk may, with the approval of the council, promulgate regulations necessary to determine and collect fees imposed and to otherwise enforce the provisions of this chapter.

ayor or Manager may take any action necessary or appropriate to the mplementation of this chapter by promulgation of regulations which may include the adoption of forms. Such regulations or any proceedings adopted by the City Mayor or Manager are effective at the time indicated by him, but are subject to revision or repeal by the city Council at the next meeting following their effective date or at the time that the Council acts thereon.

SECTION V. Effective Date. This ordinance becomes effective upon adoption by the Wasilla City Council.
