ORDINANCE SERIAL NO. 94-18

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTERS 2.02, 2.16 AND 2.64 OF THE WASILLA MUNICIPAL CODE.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

SECTION I. Classification. This ordinance is of a general and permanent nature and shall become part of the Wasilla Municipal Code.

SECTION II. Purpose. To amend the Wasilla Municipal Code to establish a mechanism for the automatic adjustments of Council, Boards and Commission and Mayoral compensation.

SECTION III. Amendment.

2.04.040 C. Effective July 1, 1997 the salary set forth in 2.04.040 B shall be adjusted, up or down, on a annual basis, such adjustment to be calculated each year and incorporated into the annual budget effective July 1 of the year of that budget process. The adjustment will be intended to reflect the percentage change in the most recently available published data establishing the fiscal year annual Consumer Price Index for the Anchorage area as established and compiled by statistics maintained by the United States Department of Labor.

2.16.060 Salary of Mayor.

A. If a manager plan has not been adopted, the City Council shall adopt a pay plan for the elected Mayor at least Sixty (60) days prior to the next regular mayoral election in order to attract the highest quality candidates. The pay plan shall not include merit increases but shall include standard city employee benefits. If a special election for Mayor is held to fill an unexpired term then the pay plan for the unexpired term shall be used. The Mayor's pay plan may not be reduced during a Mayor's term, ~~may only be raised by a two third's (2/3) vote of the City Council. Cost of living increases for city employees shall not affect the Mayor's pay plan but may include the Mayor's pay plan on approval by a two third's (2/3) majority vote of the Council in a separate vote. (Ord. 85-36-492-1985)~~ except that effective July 1, 1997, the salary shall be adjusted, on a annual basis, such adjustment to be calculated each year and incorporated into the annual budget effective July 1 of the year of that budget process. The adjustment will be intended to reflect the percentage change in the most recently available published data establishing the fiscal year annual Consumer Price Index for the Anchorage area as established and compiled by statistics maintained by the United States Department of Labor.

2.64.050 Compensation. Voting members of advisory or commissions shall receive no

compensation for their services unless specifically directed by Council. Effective July 1, 1997 if members are being compensated, said compensation shall be adjusted, up or down, on a annual basis, such adjustment to be calculated each year and incorporated into the annual budget effective July 1 of the year of that budget process. The adjustment will be intended to reflect the percentage change in the most recently available published data establishing the fiscal year annual Consumer Price Index for the Anchorage area as established and compiled by statistics maintained by the United States Department of Labor.

SECTION IV. Effective Date. This ordinance becomes effective upon adoption by the Wasilla City Council.
