ORDINANCE SERIAL NO. <u>95-27</u>

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING SECTION 1.20.100 (RESOLUTIONS INTRODUCTION, FINAL PASSAGE, EFFECTIVE DATE) OF THE WASILLA MUNICIPAL CODE.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

<u>SECTION I</u>. <u>Classification</u>. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

<u>SECTION II.</u> <u>Purpose</u>. To allow for clarification of the introduction, final passage and effective date of resolutions.

<u>SECTION III.</u> <u>Amendment.</u> Section 1.20.100 of the Wasilla Municipal Code is amended as follows:

- 1.20.100 Resolutions <u>Passage Procedure</u> Introduction, Final Passage, Effective Date.
- A. Introduction. The final version of a resolution shall be in writing in the form required in 1.20.090(B) above and the title clause of every resolution shall be read aloud \(\forall \) whether introduced at the instance of or presented by third parties, or on the motion and instance of the Council, every resolution shall be in writing in the form required in 1.20.090(B) above and shall be read aloud, unless the reading is waived by a majority vote of the Council before any vote is taken thereon.
- B. Final Passage. Council has the option to call for a public hearing on a particular resolution. Whether a public hearing is held or not. Aall persons who appear shall be given an opportunity to be heard. After such hearing, the Council may pass or reject such any resolution with or without amendments. The first reading of any a resolution shall be final unless a public hearing is requested, and at which time action shall be final.
- C. Effective Date. A resolution shall become effective upon being approved and signed unless a later effective date is specified. Any resolution not signed by the Mayor within ten days of its passage by the Council becomes effective upon the expiration of the ten days following its passage.
