ORDINANCE SERIAL NO. 97-49

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTER 2.04.040(B), SALARIES OF ELECTED OFFICERS, IN THE WASILLA MUNICIPAL CODE.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

<u>SECTION 1</u>. <u>Classification</u>. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

<u>SECTION 2</u>. <u>Purpose</u>. To comply with the intent of Council to increase their salaries in the form of compensation for attendance at special meetings, work sessions and Borough Assembly meetings.

SECTION 3. Amendment. Section 2.04.040(B) is hereby amended as follows:

2.04.040 Salaries of Elected Officers.

B. The salary for each Council Member shall be Fifty Dollars (\$50.00) per each regular Council meeting attended or absent from, due to conflicting City business <u>and Twenty-five Dollars (\$25.00) for each work session, special Council meeting and each Matanuska-Susitna Borough Assembly meeting attended as a City representative <u>spokesperson</u>. The above salary shall be subject to all applicable deductions for PERS and other Payroll deductions.</u>

<u>SECTION 4</u>. <u>Effective Date</u>. This ordinance becomes effective retroactively to July 1, 1997.
