9.04.040 Fees. Effective January 1, 1984, the license fee for each business shall be twenty-five dollars (\$25.00) for the calendar year or any part thereof. There is no renewal fee. Effective January 1, 1994 501(c)(3)(4) nonprofit organizations will be required to obtain a City of Wasilla Business License at no cost.
