

ORDINANCE SERIAL NO. 97-58

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING CHAPTER 9.04, BUSINESS LICENSE GENERAL

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

SECTION I. Classification. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

SECTION II. Purpose. To amend Chapter 9.04 by eliminating a renewal fee for business licenses.

SECTION III. Amendment. Section 9.04.040 , Fees.

9.04.040 Fees. Effective January 1, 1984, the license fee for each business shall be twenty-five dollars (\$25.00) ~~for the calendar year or any part thereof.~~ There is no renewal fee. Effective January 1, 1994 501(c)(3)(4) nonprofit organizations will be required to obtain a City of Wasilla Business License at no cost.

SECTION IV. Effective Date. This ordinance becomes effective upon adoption by the Wasilla City Council.
