ORDINANCE SERIAL NO: 97-69

AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING SECTION 9.08.040, INSURANCE REQUIRED, OF THE WASILLA MUNICIPAL CODE.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

<u>SECTION I.</u> Classification. This Ordinance is of a general and permanent nature and shall become part of the Wasilla Municipal Code.

<u>SECTION II.</u> Purpose. To amend a section of Chapter 9.08 (Insurance Required/Taxi Cabs)

SECTION III. Repeal. Section 9.08.040 (B), is hereby repealed.

<u>SECTION IV.</u> <u>Enactment</u>. Section 9.08.040 (B) of the Wasilla Municipal Code is enacted as follows:

9.08.040 Insurance Required:

B. The minimum automobile liability insurance applicable to any one vehicle in use under this Taxicab Permit shall comply with any applicable statutory requirements, and in no event be less than the following policy limits: liability limits of not less than \$100,000.00 per person and \$300,000.00 per accident, and further including \$100,000.00 \$50,000 property damage per accident; Uninsured or underinsured motorist with minimum limits as follows; \$100,000.00 per person and \$300,000.00 per accident, and further including \$100,000.00 \$50,000 property damage per accident.

SECTION V. Effective Date. This ordinance becomes effective upon adoption.
