

**CITY OF WASILLA
ORDINANCE SERIAL NO. 98-62**

AN ORDINANCE OF THE WASILLA CITY COUNCIL ADOPTING WMC 2.45, PUBLIC SAFETY DIRECTOR AND AMENDING WMC 3.35, EXEMPT EMPLOYEES TO CREATE THE POSITION OF PUBLIC SAFETY DIRECTOR.

Section 1. Classification. This ordinance is of a general and permanent nature and shall become a part of the Wasilla Municipal Code.

Section 2. Adoption of chapter. WMC 2.45, Public Safety Director, is hereby adopted to read as follows:

CHAPTER 2.45: PUBLIC SAFETY DIRECTOR

Section: 2.45.010 Appointment.

2.45.020 Duties.

2.45.010 Appointment.

The public safety director shall be appointed by the mayor and serves at the pleasure of the mayor and is an exempt, at-will employee.

2.45.020 Duties.

The public safety director reports to the mayor on all public safety matters. The position is responsible for strategic planning in the area of public safety; coordinates with all emergency services serving the city; and exercises authority over the Wasilla Police Department and any future public safety entities.

Section 3. Amendment of subsections. WMC 3.35.010(A) and (B), Exempt Employees, are hereby amended to read as follows:

(A)[.] Sections 3.35.010 through 3.35.080 of this chapter **shall** apply [ONLY] to **the** [THOSE] exempt employees [OF THE CITY] listed in subsection B of this section. **Other executive, professional or administrative employees may be specified at the discretion of the mayor.** In the event any provision of **this s[Section]**[S 3.35.010 THROUGH 3.35.080] conflicts with any other provisions of this chapter, Sections 3.35.010 through 3.35.080 shall govern.

(B)[. SECTIONS 3.35.010 THROUGH 3.35.080 APPLY TO AND GOVERN THE ITEMS AND CONDITIONS OF EMPLOYMENT OF] I[t]he following [EXEMPT] positions **are exempt:**

(1)[.] [THE] Deputy Administrator;

(2)[.] [THE] City Clerk;

(3)[.] [THE] City Attorney;

(4)[.] [THE] Chief of Police;

(5)[.] [THE CITY] Library Director;

(6)[.] [THE CITY] Museum Director;


(7)[.] [THE CITY] Finance Director;

(8)[.] **Public Works Director;**

(9)[.] **Public Safety Director**[OTHER EXECUTIVE, PROFESSIONAL OR ADMINISTRATIVE EMPLOYEES AS MAY BE SPECIFICALLY DESIGNATED IN THE DISCRETION OF THE MAYOR].

Section 4. Effective date. This ordinance shall take effect upon adoption of the Wasilla City Council.
