AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC CHAPTER 9.12,

PUBLIC VENDING.

WHEREAS, it is in the public interest of the City of Wasilla and its residents that

vendors of products and services operating under municipal licenses pose no danger to the

public relating to physical and emotional safety (particularly of children) and engage in

honest and appropriate business practices.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA:

**Section 1.** Classification. This ordinance is of a general and permanent nature

and shall become a part of the Wasilla Municipal Code.

Section 2. Amendment of section. WMC 9.12.060(4), Application For Permit,

is hereby amended to read as follows:

9.12.060 APPLICATION FOR PERMIT.

(4) A background check of the criminal history of applicant, and those persons

running or controlling the business and those persons to be in contact with the public on

behalf of the applicant, including felony charges, drug offenses, and sex offenses [FOR THE

PAST FIVE YEARS]. If the applicant applying for a roving vendor permit involves the

operation of a motor vehicle, the applicant must include a background check of motor vehicle

violations [FOR THE PAST FIVE YEARS].

**Section 3.** Amendment of section. WMC 9.12.070(B) Permit Conditions, is hereby amended to read as follows:

## 9.12.070 PERMIT CONDITIONS.

(B) No permit will be issued to an applicant <u>or to a business owned or controlled</u>

<u>by any person</u> who has been convicted of a felony, or a crime involving fraud, dishonesty, or deception, <u>or</u> child molestation or related crime [WITHIN FIVE YEARS PRIOR TO THE DATE OF THE APPLICATION].

**Section 4.** Amendment of section. WMC 9.12.090 Revocation or Suspension of Permit, is hereby amended to read as follows:

## 9.12.090 REVOCATION OR SUSPENSION OF PERMIT.

(B) A permit will be revoked if any owner or operator of a permitted business, or any agent or employee in contact with the public on behalf of the permittee, is or has been convicted of a felony or a crime involving fraud, dishonesty, or deception, or child molestation, or related crime.

**Section 5. Effective date.** This ordinance is effective upon adoption by the Wasilla City Council.
