ORDINANCE SERIAL NO. 00-04**

AN ORDINANCE OF THE WASILLA CITY COUNCIL, ALASKA AMENDING THE FY00 BUDGET BY APPROPRIATING FUNDS TO THE CIP FUND FOR THE DEVELOPMENT OF SPORTS FACILITIES AT THE BUMPUS RECREATIONAL AREA.

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

Section 1. Classification. This ordinance is a non-code ordinance.

Section 2. Purpose. To appropriate funds within the General Fund for the purpose of developing sports facilities at the Bumpus Recreational Facility.

Section 3. Appropriation. Funds are appropriated within the following fund:



SUMMARY:

Now that Mystery Avenue is substantially complete, work can begin on constructing more sports facilities. We are working with the soccer association in developing fields to the south of Mystery Ave. This winter, work can begin on site preparation for a driveway and the fields. Surveying needs to be done and a hydro-axe may be available for clearing vegetation. Also, a well may be installed and power line brought in to the areas.

An agreement with the soccer association is being prepared and they have indicated that they have funds available and are also applying for a grant from the national association. A tentative schedule would be to prepare and install the parking lot and two soccer fields in summer, 2000 with use beginning in 2001.


