

**CITY OF WASILLA
ORDINANCE SERIAL NO. 00-17**

AN ORDINANCE OF THE WASILLA CITY COUNCIL REPEALING SECTIONS OF THE WASILLA MUNICIPAL CODE 2.20.010 MEETINGS PUBLIC, 2.20.060 OATH OF OFFICE, 2.20.080 PROHIBITIONS, 2.20.120 COMBINING OFFICES, 2.24 CITY MANAGER.

BE IT ENACTED:

* **Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

* **Section 2. Repeal of sections.** WMC 2.20.010 Public Meetings, 2.20.060 Oath of Office, 2.20.090 Prohibitions, 2.20.120 Combining Offices, are hereby repealed as follows:

[2.20.010 MEETINGS PUBLIC.

ALL REGULAR AND SPECIAL MEETINGS OF THE COUNCIL SHALL BE OPEN TO THE PUBLIC AND THE PUBLIC SHALL HAVE THE REASONABLE OPPORTUNITY TO BE HEARD.

2.20.060 OATH OF OFFICE.

ALL MUNICIPAL OFFICERS, BEFORE TAKING OFFICE, SHALL AFFIRM IN WRITING THAT THEY WILL HONESTLY, FAITHFULLY, AND IMPARTIALLY PERFORM THEIR DUTIES. THE OATH SHALL BE FILED WITH THE MUNICIPAL CLERK.

2.20.080 APPOINTMENT OF OFFICERS.

THE CITY CLERK, ATTORNEY, FINANCE DIRECTOR AND POLICE CHIEF ARE APPOINTED BY THE MAYOR OR BY THE COUNCIL, AS DETERMINED BY ORDINANCE. APPOINTIVE OFFICERS SERVE AT THE PLEASURE OF THE APPOINTING AUTHORITY, SUBJECT TO ORDINANCE. APPOINTMENTS BY THE MAYOR ARE SUBJECT TO CONFIRMATION BY COUNCIL.

2.20.090 PROHIBITIONS.

NO PERSON MAY BE APPOINTED TO OR REMOVED FROM MUNICIPAL OFFICE OR IN ANY WAY FAVORED OR DISCRIMINATED AGAINST WITH RESPECT TO A MUNICIPAL POSITION BECAUSE OF HIS RACE, COLOR, SEX, CREED, NATIONAL ORIGIN OR, UNLESS OTHERWISE CONTRARY TO LAW, BECAUSE OF HIS POLITICAL OPINIONS OR AFFILIATIONS.

2.20.120 COMBINING OFFICES.

THE COUNCIL MAY COMBINE TWO OR MORE APPOINTIVE OR ADMINISTRATIVE OFFICERS.]


* **Section 3. Repeal of chapter.** WMC 2.24 City Manager, is hereby repealed as follows:

[2.24.010 ADOPTION OF MANAGER PLAN.

A MUNICIPALITY MAY ADOPT A MANAGER PLAN OF GOVERNMENT BUT THIS MAY BE EXERCISED ONLY AS PRESCRIBED BY ALASKA STATUTES 29.20.460-29.20.520.]

* **Section 4. Effective date.** This ordinance shall take effect upon adoption of the Wasilla City Council.
