AN ORDINANCE OF THE WASILLA CITY COUNCIL, AMENDING THE FY-00 BUDGET BY APPROPRIATING FUNDS FROM THE GENERAL FUND TO ACQUIRE LAND TO CONSTRUCT A NEW CITY SHOP (IM NO. 00-38)

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS FOLLOWS:

Section 1. Classification. This ordinance is a non-code ordinance.


Section 2. Purpose. Appropriate additional funds to the FY00 Capital Fund to construct a maintenance shop and install a storm drain system.

Section 3. Appropriation. Funds are appropriated to the Capital Improvement Fund: 11-55-475-831-11 New Maintenance Shop \$65,000

Section 4. Source of Funds.
General Fund, fund balance \$65,000

Section 5. Effective Date. This ordinance shall take effect upon adoption of the Wasilla City Council.

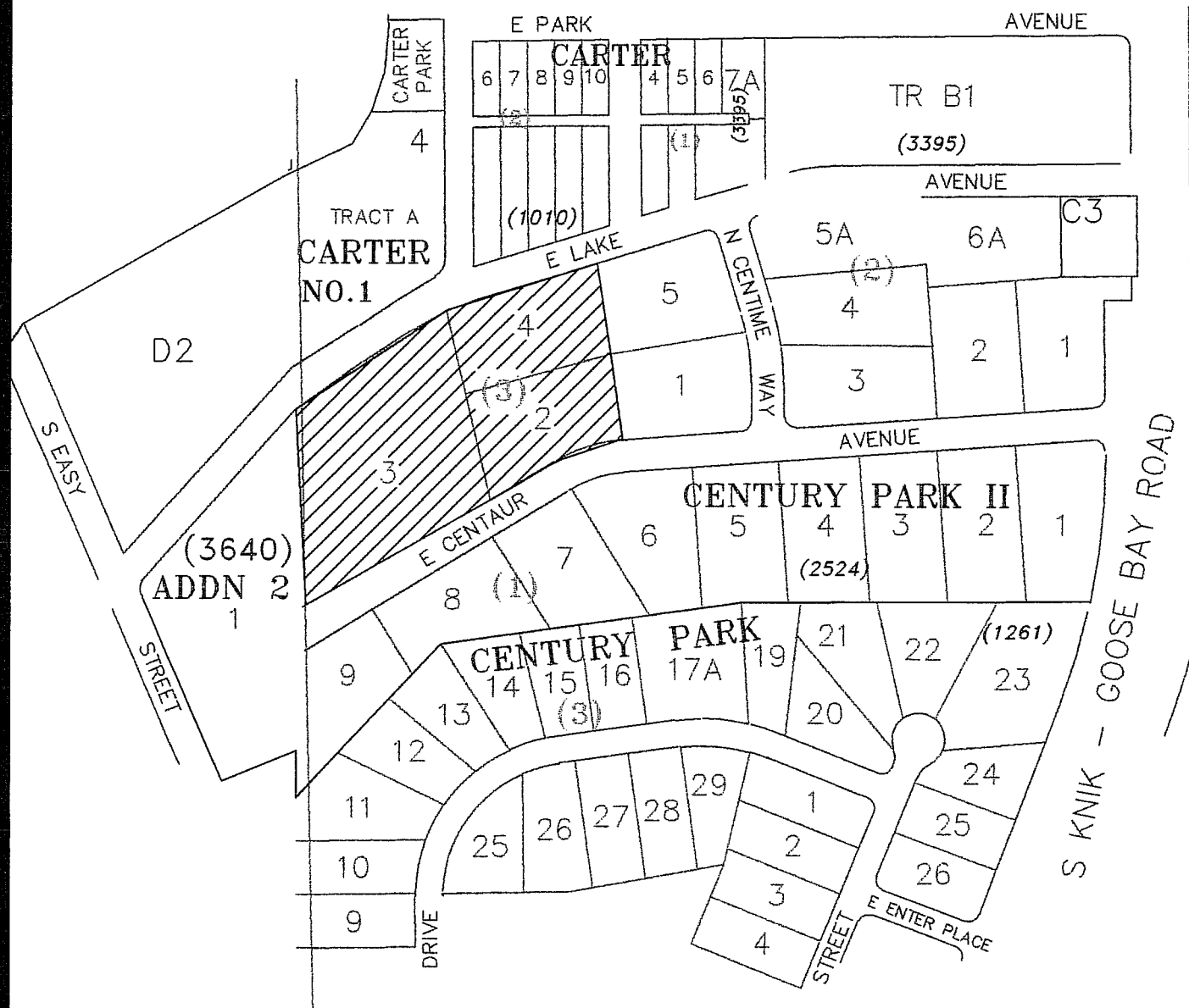

RESOLUTION SERIAL NO. 00-13**

A RESOLUTION OF THE WASILLA CITY COUNCIL APPROVING THE PURCHASE OF BLOCK 3, LOT 3 CENTURY PARK II FOR USE AS A PUBLIC WORKS FACILITY TO INCLUDE A WATER WELL SITE, STORM DRAINAGE, AND MAINTENANCE YARD.

WHEREAS, Public Works is in need of property to site a new storm drain facility, to maintain and protect an existing water well site and to construct a new maintenance yard, and;

WHEREAS, the existing maintenance yard is inadequate for current and future maintenance needs, and;

WHEREAS, the proposed site for purchase is in an area zoned for commercial use, and;

WHEREAS, it is the intent of Public Works to purchase additional property adjacent to this property to meet future requirements for a maintenance yard, and;

WHEREAS, Ordinance Serial Number 00-23 provides funding for purchase of this property.

NOW THEREFORE BE IT RESOLVED, by the Wasilla City Council supports the purchase of Block 3, Lot 3, Century Park II for various purposes required by Public Works, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the terms will be a cash sale.

SUMMARY:

The City of Wasilla has been the recipient of a steady growth and expansion rate within and adjacent to its boundaries which has led to an increased demand and need for the City to provide services. In providing these services, the City has experienced an increase in personnel and equipment needed to meet this demand. The current City Shop has become inadequate because of over crowding, drainage problems, lack of expansion area, inefficient shape and size of the yard, and location in an area incompatible with the current zoning regulations.

The proposed land purchase are lots 2, 3 and 4, block 3 Century Park II Subdivision. These lots are level, have little vegetative growth on them, are well drained and all utilities are available to the properties. The City of Wasilla is currently negotiating the purchase of lot 3 for use in the storm drain project and as a short term back up well for the area. Costs savings in the storm drain project are \$30-40,000 versus alternative routes. With the additional purchase of lots 2 and 4, the city would have a total area of 5 plus acres of land for a City Shop in an area zoned Commercial that is centrally located to the core area. Public Works is proposing to build a maintenance building with an intended 15-20 year life cycle. The purchase of this property for a maintenance building and route for a storm drain system from the parks Highway has been discussed in a Council work session a few weeks ago. The purchase of the two additional parcels will be brought to the Council once negotiations are completed.




