**AN ORDINANCE OF THE CITY OF WASILLA, ALASKA PROVIDING FOR THE  
 ADOPTION OF THE BUDGET FOR THE FISCAL YEAR 2001 AND APPROPRIATING  
 FUNDS TO CARRY OUT SAID BUDGET.**

BE IT ORDAINED AND ENACTED BY THE CITY OF WASILLA, ALASKA AS  
 FOLLOWS:

**Section 1. Classification.** This is a non-code ordinance.

**Section 2. Purpose.** In accordance with WMC 6.04.020, the Wasilla City Council hereby adopts the operating budget for the Fiscal Year 2001, as presented by the Mayor and introduced on April 24, 2000.

**Section 3. Appropriation.** There is hereby authorized and appropriated for expenditures and transfers, the sum of \$8,469,571 in accordance with the attached budget proposals.




