AN ORDINANCE OF THE CITY OF WASILLA, ALASKA AMENDING THE FY-01 BUDGET BY APPROPRIATING FUNDS TO THE SEWER FUND FOR THE CITY OF WASILLA'S SHARE OF THE COST OF THE ALTERNATIVE SCHOOL SEWER MAINLINE EXTENSION.

BE IT ORDAINED:

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To appropriate additional funds to the Sewer Fund for the City of Wasilla's share of the cost of the Alternative School Sewer Mainline Extension.

Section 3. Appropriation. Funds are appropriated to the following fund:

SUMMARY:

A supplemental appropriation is requested in Ordinance 00-56 to fund the City-portion of a new sewer line to the remodeled alternative school. Spenard Builder's Supply will also be added to this system. This six inch line will extend from Lake Lucille Dr. under the railroad tracks through Spenard Builders yard and under the Parks highway to the school. Over-sizing the line to six inches will allow expansion to the west and north as these areas develop. It is anticipated that the line will be built to Spenard Builders this fall while construction to the school will be done next construction season.

The school district will fund \$35,000 and Spenard Builders will fund \$42,500 for the line. City of Wasilla previously agreed to pay \$25,000 for the installation. The additional \$28,000 is to pay for over-sizing of the line from two to six inches to allow for future extensions.
