# CITY OF WASILLA ORDINANCE SERIAL NO. 01-02

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 2.20.020, CITY CLERK APPOINTMENT, WMC 2.28.020, FINANCE DIRECTOR APPOINTMENT - TERM, WMC 2.32.020, POLICE CHIEF APPOINTMENT, WMC 2.36.020, PUBLIC WORKS DIRECTOR APPOINTMENT AND ADMINISTRATION, WMC 2.52.020, LIBRARY DIRECTOR APPOINTMENT - TERM AND REPEALING WMC 2.34, PUBLIC SAFETY DIRECTOR.

## BE IT ENACTED:

- \* Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.
- \* Section 2. Amendment of section. WMC 2.20.020, Appointment, is amended to read as follows:
- A. The city clerk shall be appointed by the council <u>and serve at the pleasure</u> of the council.
- B. The deputy city clerk shall be [A CLASSIFIED POSITION UNDER ALL THE RULES AND REGULATIONS ESTABLISHED IN TITLE 3, PERSONNEL, EXCEPT THAT THE DEPUTY CITY CLERK SHALL BE] appointed by the city clerk [SUBJECT TO CONFIRMATION] and confirmed by the city council. The deputy clerk shall be a classified position.

\* Section 3. Amendment of section. WMC 2.28.020, Appointment - Term, is amended to read as follows:

2.28.020 Appointment [– TERM].

The finance director shall be appointed by the mayor and serve at the pleasure of the mayor.

\* Section 4. Amendment of section. WMC 2.32.020, Appointment, is amended to read as follows:

2.32.020 Appointment.

The [DEPARTMENT HEAD WILL BE THE CHIEF OF] police <u>chief</u> [WHO] shall be appointed by the mayor [/MANAGER PURSUANT TO TITLE, PERSONNEL] <u>and</u>

# serve at the pleasure of the mayor.

\* Section 5. Amendment of section. WMC 2.36.020, Appointment and administration, is amended to read as follows:

2.36.020 Appointment. [AND ADMINISTRATION]

The public works director shall be appointed by the mayor and serve[S] at the pleasure of the mayor.

\* Section 6. Amendment of section. WMC 2.52.020, Appointment - Term, is amended to read as follows:

2.52.020 Appointment [- TERM]

The [ADMINISTRATIVE LIBRARIAN] <u>library director</u> shall be appointed by the mayor [WITH RATIFICATION BY THE ADVISORY LIBRARY BOARD] and serve at the pleasure of the mayor.

\* Section 7. Repeal of Title. WMC 2.34, Public Safety Director, is repealed in its entirety:

[2.34.010 APPOINTMENT.

THE PUBLIC SAFETY DIRECTOR SHALL BE APPOINTED BY THE MAYOR AND SERVES AT THE PLEASURE OF THE MAYOR AND IS AN EXEMPT, AT-WILL EMPLOYEE.

2.34.020 DUTIES

THE PUBLIC SAFETY DIRECTOR REPORTS TO THE MAYOR ON ALL PUBLIC SAFETY MATTERS. THE POSITION IS RESPONSIBLE FOR STRATEGIC PLANNING IN THE AREA OF PUBLIC SAFETY; COORDINATES WITH ALL EMERGENCY SERVICES SERVING THE CITY; AND EXERCISES AUTHORITY OVER THE WASILLA POLICE DEPARTMENT AND ANY FUTURE PUBLIC SAFETY ENTITIES.]

\* Section 8. Effective date. This ordinance shall take effect upon adoption of the Wasilla City Council.
