SUMMARY:

During the construction of Spruce Avenue in 1999, additional right-of-way (ROW) was required to construct the new road way to Church Road. The property effected is located in Silverleaf Estates, Tract A4. In negotiations with the property owners, the option was left to them for the City to either acquire the entire parcel or for the City to pay for the required ROW only.

The owners opted to sell the ROW only and retain ownership of the rest of the parcel. In negotiations with the owner, the City has agreed, with approval of the Council, to purchase this ROW for \$38,000. If the owners opted to sell the property to the City, it would have cost the City \$48,000, the original appraised value of the property. This also would have resulted in the City having to re-sell the parcel at some point because it is of no value to the City for other purposes. The current appraisal for this property is \$23,000.

Resolution 01-12 will be submitted at the April 23, 2001 Council meeting to approve the purchase of the ROW from the owners of Silverleaf Estates.
