SUMMARY: Funding is needed to conduct preliminary engineering for Lucille Street water and sewer extensions to Valley Residential Services Low to Middle Income (LMI) Housing project. Preliminary engineering is needed so this project can be completed this year. The LMI Housing project is expected to need water and sewer service by March 2002. Public Works has identified \$15,000 from a City Road Project (Storm Water Rehab. 11-55-473-841-08) that can be used for the Lucille Street water and sewer extensions. This funding was originally allocated to evaluate the Carrs parking lot stromwater system, to determine if it could be used to receive runoff from Swanson Avenue. This no longer appears to be feasible, due to the projected maintenance costs associated with the Carrs stormwater system. Full funding for the Lucille Street water and sewer extensions is expected in July 2001.
