GRANT PRELIMINARY ENGINEERING.**

BE IT ORDAINED

**Section 1. Classification.** This is a non-code ordinance.

**Section 2. Purpose.** To appropriate funds for preliminary engineering required to apply for an earmarked Federal Transit Authority Grant in the Amount of \$600,000.

**Section 3. Appropriation.** Funds are appropriated to the following fund:

**Section 4. Source of Funds.**

**SUMMARY:** The City received a \$600,000 earmark Federal Transit Authority (FTA) Grant last year for a maintenance facility. The administration is proposing to join with MASCOT and their FTA grant funding in a combined maintenance facility. FTA is requiring that ADOT, ARRC, MASCOT and the City conduct preliminary engineering and an environmental assessment to ensure all of the FTA funded projects in the Mat-Su area are compatible. The ARRC is using an existing \$900,000 grant for the Wasilla area to conduct the preliminary engineering and an environmental assessment. To join this planning effort, the City and MASCOT need to provide a 20% match towards the planning grant, which is \$13,000.

The City recently received \$94,000 from the Mat-Su Borough that reimbursed the City for a portion of the paving it completed last year, as part of the Borough's annual TORA program. The administration is proposing to use \$13,000 of this funding for the FTA preliminary engineering and environmental assessment.

**FISCAL IMPACT:** \$13,000 32-55-620-491-00

**RECOMMENDED ACTION:** Council is requested to approve Ordinance Serial N. 02-45 that appropriates \$13,000 for FTA preliminary engineering.
