**CITY OF WASILLA
 ORDINANCE SERIAL NO. 02-49**

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WASILLA MUNICIPAL CODE (WMC) 5.16.100 (3), COLLECTION OF SALES TAX – ADDITION AND SEPARATE STATEMENT.

* **Section 1. Classification.** This ordinance is of a general and permanent nature and shall become part of the city code.

* **Section 2. Amendment of section.** WMC 5.16.100 (3), Collection of sales tax – Addition and separate statement, is amended to read as follows:

5.16.100 (3) Sales Tax – Addition and separate statement.


3. The amount of sales tax to be added to the price of a sale, rental or service shall be determined in accordance with the following schedule:

<u>\$.20 through \$.59</u> [\$25 THROUGH \$.64]	\$.01
<u>\$.60 through \$.99</u> [\$.65 THROUGH \$1.24]	\$.02
<u>\$1.00 through \$1.39</u> [\$1.25 THROUGH \$1.64]	\$.03
<u>\$1.40 through \$1.79</u> [\$1.65 THROUGH \$2.24]	\$.04
<u>\$1.80 through \$2.19</u> [\$2.25 THROUGH \$2.64]	\$.05
<u>\$2.20 through \$2.59</u> [\$2.65 THROUGH \$3.24]	\$.06
<u>\$2.60 through \$2.99</u> [\$3.25 THROUGH \$3.64]	\$.07
<u>\$3.00 through \$3.39</u> [\$3.65 THROUGH \$4.24]	\$.08
<u>\$3.40 through \$3.79</u> [\$4.25 THROUGH \$4.64]	\$.09

Over <u>\$4.19</u> [5.24], continue on same scale up to five hundred dollars (\$500.00).
