AN ORDINANCE OF THE CITY OF WASILLA, ALASKA TO AMEND THE FY-03 BUDGET TO APPROVE AND ACCEPT A MINOR CONSUMING GRANT IN THE AMOUNT OF \$5,000 FROM THE STATE DEPARTMENT OF TRANSPORTATION AND REVISE THE REVENUE AND EXPENDITURE BUDGET ACCOUNTS IN THE YOUTH COURT SPECIAL REVENUE FUND TO MATCH ACTUAL REVENUE BEING REALIZED FROM VARIOUS GRANT AND CONTRIBUTION SOURCES

BE IT ORDAINED:

Section 1. Classification.

This is a non-code ordinance.

Section 2. Purpose. To accept and approve a State Department of Transportation \$5,000 Minor Consuming Diversion grant, number 030204AL, to Youth Court.

To revise the Youth Court Special Revenue Fund expense and revenue budget to reflect the actual amounts being realized from various grant and contribution sources.

Some grants that were originally budgeted in FY03 were not approved. Others were awarded for a different amount than anticipated and budgeted, and local contributions have been realized at a higher rate than originally budgeted. Therefore, a revision of the budget is necessary for expenditures to match the actual level of funding.
