AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 5.04.150, TRANSFER OF APPROPRIATIONS, CONCERNING THE AUTHORITY OF THE MAYOR TO TRANSFER FUNDS WITHIN AN ACCOUNTING FUND AND A DEPARTMENT.

- BE IT ENACTED:
- \* Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.
- \* Section 2. Amendment of section. WMC 5.04.150, transfer of appropriations, is amended to read as follows:
- 5.04.150 Transfer of appropriations.

No transfer of an appropriation from one accounting fund to another accounting fund may be made except by ordinance appropriating the funds. Within an accounting fund, the council may by resolution transfer part or all of any unencumbered funds among functions [or], activities and departments. The mayor may transfer part or all of any unencumbered funds within a department and may transfer part or all of any unencumbered funds between departments up to \$10,000 per fiscal year. [ANY DEPARTMENT, FUNCTION OR ACTIVITY UP TO FIVE THOUSAND DOLLARS (\$5,000.00) PER LINE ITEM PER FISCAL YEAR].

\* Section 3. Effective date. This ordinance shall take effect upon adoption by the Wasilla City Council.
