

- \* **Section 1. Classification.** This is a non-code ordinance.
- \* **Section 2. Purpose.** To appropriate State of Alaska Grant funding for one-half of the match for the FAA Grant that will fund 93.75 percent of the project, and to authorize the administration to execute the grant agreement.
