## SUMMARY:

To appropriate and amend the FY'04 Sports Complex budget from the General Fund in the amount of \$132,687 and projected revenue from the Sports Complex in the amount of \$96,000.

As with any new facility start up, many of the costs are unknowns until some history of expenditures and use is established. While the revenues for the remainder of the fiscal year are projected much lower than the expenditures primarily for two reasons. One is that this time of year, March through June, as the outdoor temperature gets warmer the use of an indoor facility decreases. The other is that while there is high interest in the use of the facility, the unknown of the actual use still remains. Should there be as much use as interest shown, revenues will increase and subsequently will decrease the deficit.
