* **Section 1. Classification.** This is a non-code ordinance.

* **Section 2. Purpose.** To amend the FY04 Cultural & Recreation budget by accepting and appropriating funds from the State of Alaska, Dept of Community & Economic Development mini-grant to contract for a Market Analysis for the Sports Complex.


