SUMMARY STATEMENT: As stated in Ordinance Serial No. 04-07, this ordinance sets up a budget for the city of Wasilla to operate its own dispatch center. Most of the funding for the budget will come from funds budgeted to pay for dispatch services from the city of Palmer. \$9,232 of more funding will be needed to fund the estimated cost of dispatch for the city of Wasilla. The reason for the total increase in funding is due to the fact that the city of Wasilla is paying the city of Palmer \$24,347 for dispatch services for the month of January 2004 while the city of Wasilla completes the setup of its dispatch center.

The city of Wasilla has hired 6 dispatchers, which started on January 2, 2004. The police department estimates that the city of Wasilla will be fully operational by February 1, 2004.
