* Section 1. Classification. This ordinance is of a general and permanent

nature and shall become part of the city code.

* Section 2. Amendment of section. WMC 2.44.060, Compensation, is

amended to read as follows:

A. A commission member shall be eligible for compensation, provided that

the commission is established by codified ordinance, which sets forth the amount of

compensation a member, is entitled to receive.

B. For the purposes of compensation, meetings are construed as official

when advertised, and shall include regularly scheduled and special or emergency

meetings, [AND] work sessions, and each Wasilla City Council meeting attended as

an official commission representative.

C. Except as provided in B of this section, compensation shall not be paid for

a member's attendance at external meetings, training or informal activities which are not

official and advertised sessions of the commission.

Section 3. Effective date. This ordinance shall take effect upon adoption of

the Wasilla City Council.
