AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-05 PLANNING BUDGET BY ACCEPTING AN INCREASE OF \$10,000 FOR THE HAZARD MITIGATION GRANT FROM THE DEPARTMENT OF MILITARY AND VETERANS AFFAIRS DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT.

* **Section 3. Appropriation.** Funds are appropriated to the following:



SUMMARY STATEMENT:

Federal regulations required every local government to adopt a mitigation plan that describes the process for identifying risks, levels of vulnerabilities, and prioritizing mitigation actions for natural hazards by November 2004. Communities were required to meet this deadline in order to receive federal funds in the event of a disaster.

The City applied for a Hazard Mitigation Grant in 2003 to assist in preparation of the required plan. However due to restructuring at the federal level to create the Homeland Security Department and several high priority state and national emergencies, the awarding of these Hazard mitigation grants was delayed.

To meet the November 2004 deadline, the Planning Department, working with the Planning Commission, developed phase one of the Wasilla All Hazard Mitigation Plan. Phase I deals with natural hazards as required by the federal regulations. On July 27, 2004 the Planning Commission recommended that Phase I be forwarded to the City Council and the Alaska Division of Emergency Services for their review. The State Hazard Mitigation Officer reviewed and accepted Phase I of the Wasilla Hazard

Mitigation Plan and forwarded it to the Federal Emergency Management Agency in time to meet the federal deadline.

The notification that Wasilla has received a \$10,000 Hazard Mitigation grant will allow the Planning Department to prepare Phase II of the City's All Hazard Mitigation Plan. Phase II will deal with man-made hazards.
