



SUMMARY STATEMENT: This ordinance appropriates \$6,096 Department of Commerce, Community and Economic Development Grant funds and transfers \$3,904 Matching City Funds totaling \$10,000 for Bumpus Ballfield Complex to assist in the construction of a second soccer field and parking lot.
