**SUMMARY STATEMENT:** Recreation Services has applied for and received an Alaska Community Forestry Program Grant. This grant will be used to purchase a Global Positioning System (GPS) unit to track trees that are being planted and maintained by the city. This will be an invaluable asset to maintaining our tree inventories. This system will be helpful for tracking regularly scheduled care and maintenance of trees.

The grant will also provide trainings for employees and volunteers conducted by a local arborist. The training will include information in tree care and specific tree species that can be planted successfully in the Wasilla area.

A brochure that was developed several years ago for tree care and planting specific to the Wasilla area will be reprinted and provided to the public.
