AN ORDINANCE OF THE WASILLA CITY COUNCIL ACCEPTING AND APPROPRIATING A POLICE TRAINING AND THINKING DRIVER TRAINING GRANT IN THE AMOUNT OF \$3,800 FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY'S ALASKA POLICE STANDARDS COUNCIL.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY-05 Police budget by appropriating \$3,800 from the State of Alaska Department of Public Safety's Alaska Police Standards Council for the purpose of supporting police related training for the Wasilla Police Department.

Section 3. Appropriation. Funds are appropriated to the following fund:


