AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC 3.55.100.D; PAY FOR SPECIAL TYPES OF APPOINTMENTS/ASSIGNMENTS (SHIFT DIFFERENTIAL) TO PROVIDE THAT A SHIFT DIFFERENTIAL OF 2.5 PERCENT SHALL BE PAID FOR ANY SHIFT STARTING BETWEEN 12:00:00 HOURS AND 19:59:00 HOURS AND A SHIFT DIFFERENTIAL OF 5.0 PERCENT SHALL BE PAID FOR ANY SHIFT STARTING BETWEEN 20:00:00 HOURS AND 03:59:00 HOURS.

WHEREAS the City wishes to provide additional "shift differential" pay for employees who perform services during night shifts of 2.5 percent for employees who begin working a shift between 12:00:00 hours and 19:59:00 hours, and 5.0 percent for employees who begin working a shift between 20:00:00 hours and 03:59:00 hours.

- * Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.
- * Section 2. Amendment of section. WMC Section 3.55.100.D, Shift Differential, is amended as follows:
- D. Shift Differential. Employees who are assigned to [NIGHT] shifts that commence between 12:00:00 hours and 19:59:00 hours will be paid two and one half percent above the rate normally received for day time work in the same position, and employees who are assigned to shifts that commence between 20:00:00 hours and 03:59:00 hours will be paid five percent above the rate normally received for day time work in the same position. Employees who are entitled to overtime in accordance with WMC 3.60.070 shall be paid the entire shift

differential percentage for every hour of overtime worked during a shift that entitles them to receive shift differential pay.

* Section 3. Effective date. This ordinance shall take effect on July 1st, 2005.
