AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-06 POLICE DEPARTMENT BUDGET BY APPROPRIATING FROM THE STATE OF ALASKA, ALASKA HIGHWAY SAFETY OFFICE FUNDS IN THE AMOUNT OF \$1,840.00 FOR OVERTIME FOR THE 2005 DUI CAMPAIGN.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY-06 Police Department budget by appropriating \$1,840. from the State of Alaska, Alaska Highway Safety Office funds to be applied to the police budget for overtime and vehicle maintenance to enforce the FY 2005 DUI campaign.

Section 3. Appropriation. Funds are appropriated to the following funds:

Overtime: 001-4230-420.10-30 \$1,840.

Section 4. Source of Funds.

Impaired Driving (DUI) Campaign: 001-4200-334.10-08 \$1,840.

Section 5. Effective Date. This ordinance shall take effect upon adoption by the Wasilla City Council.
