Notwithstanding any other provision of this chapter, the city council may approve special incentive pay programs for eligible employees of certain departments in accordance with policies developed by the mayor.

* Section 3. Effective date. This ordinance shall take effect upon adoption of the Wasilla City Council.

SUMMARY STATEMENT:

This ordinance is amending WMC 3.55.100 - Pay for special types of appointments/assignments to add a subsection F: Special Incentive Pay Programs with Approval of City Council.

The Code section will allow the Council to approve special incentive pay programs. The Council will have more flexibility in the personnel code to setup pay structures that meet the needs of the City in a constantly changing environment. Special incentive pay programs can be added or deleted based on a current need of the City much easier than it would be to redesign the city's salary grades and pay structure every time a need is identified. Incentive pay programs can be used by the Council like incentive pay programs are used in the private sector to be performance tools in motivating employees to reach goals and objectives that the Council deems are critical to the operation of the City, life/safety of the employees and efficiency (cost savings) of City operations.
