AN ORDINANCE OF THE WASILLA CITY COUNCIL REQUESTING AUTHORIZATION TO CARRY OVER GRANT FUNDS IN THE AMOUNT OF \$5,000 FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY'S ALASKA POLICE STANDARDS COUNCIL FROM THE FY-05 POLICE DEPARTMENT BUDGET TO THE FY-06 POLICE DEPARTMENT BUDGET FOR PATROL TRAINING.

Section 1. Classification. This is a non-code ordinance.

Revenue Account: 001-4200-334.20-01 \$5,000


Section 5. Effective Date. This ordinance shall take effect upon adoption by the Wasilla City Council.
