SUMMARY STATEMENT: The City of Wasilla Police Department wishes to amend the FY-06 Police Department budget by \$1,000, appropriating funds from the Click It Or Ticket Seatbelt Enforcement incentive program for the purchase of a rifle for the Department's motorcycle. The motorcycle clearly does not provide the same environment for weapons that is present in a patrol car. This is a rifle that is manufactured with a short barrel/stock to fit the storage capabilities of the motorcycle and requires a class 3 permit from ATF.
