**AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-06 POLICE DEPARTMENT BUDGET BY APPROPRIATING FUNDS FROM THE CLICK IT OR TICKET SEATBELT ENFORCEMENT INCENTIVE PROGRAM FROM THE STATE OF ALASKA, ALASKA HIGHWAY SAFETY OFFICE FOR THE PURCHASE OF A RIFLE FOR THE DEPARTMENT'S MOTORCYCLE IN THE AMOUNT OF \$1,000.**

**Section 1. Classification.** This is a non-code ordinance.

**Section 2. Purpose.** To amend the FY-06 Police Department budget by appropriating \$1,000 from the State of Alaska, Alaska Highway Safety Office funds which were made available due to an incentive program for the Click It Or Ticket Seatbelt Enforcement to be applied to the purchase of a rifle for the motorcycle.

**Section 3. Appropriation.** Funds are appropriated to the following funds:



**Section 4. Source of Funds.**


Miscellaneous Revenue:            001-4200-334.10-08            \$1,000.00.

**SUMMARY STATEMENT:** The City of Wasilla Police Department wishes to amend the FY-06 Police Department budget by \$1,000, appropriating funds from the Click It Or Ticket Seatbelt Enforcement incentive program for the purchase of a rifle for the Department's motorcycle. The motorcycle clearly does not provide the same environment for weapons that is present in a patrol car. This is a rifle that is manufactured with a short barrel/stock to fit the storage capabilities of the motorcycle and requires a class 3 permit from ATF.

**Staff Recommendation:**

Amend the FY06 Police budget and appropriate from the State of Alaska, Alaska Highway Safety Office's Click It Or Ticket Seatbelt Enforcement incentive program for the purchase of a rifle for the Department's motorcycle in the amount of \$1,000.
