**Section 1.** Classification. This is a non-code ordinance.

Section 2. Purpose. The purpose of the ordinance is to amend the FY-06 Police Department budget by (i) reducing by \$5,053.00 the amount appropriated from the State of Alaska, Alaska Highway Safety Office grant for overtime and vehicle expenses during the Click It Or Ticket Seatbelt Enforcement Blitz from September 9 through 19, 2005, and (ii) reducing by \$681.00 the amount appropriated from the State of Alaska, Alaska Highway Safety Office grant for the Strategic Evaluation States DUI Campaign for 2005; in each case to equal the amount of grant funds actually expended.
