AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-06 POLICE DEPARTMENT BUDGET BY APPROPRIATING FUNDS FROM THE STATE OF ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, DIVISION OF MEASUREMENT STANDARDS AND COMMERCIAL VEHICLE ENFORCEMENT IN THE AMOUNT OF \$3,315.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY-06 Police Department budget by appropriating \$3,315 from the State of Alaska, Department of Transportation & Public Facilities, Division of Measurement Standards and Commercial Vehicle Enforcement funds to be applied to the police budget for vehicle inspections.

Section 5. Effective Date. This ordinance shall take effect upon adoption by the Wasilla City Council.
