AN ORDINANCE OF THE WASILLA CITY COUNCIL TO AMEND THE FY-07 POLICE DEPARTMENT BUDGET BY APPROPRIATING FROM THE STATE OF ALASKA DEPARTMENT OF TRANSPORTATION FUNDS IN THE AMOUNT OF \$50,000 FOR CONSTRUCTION ZONE ENFORCEMENT.

Section 1. Classification. This is a non-code ordinance.

Section 2. Purpose. To amend the FY-07 Police Department budget by appropriating \$50,000 from the State of Alaska Department of Transportation to be applied to the police patrol overtime pay for construction zone enforcement.

Section 3. Appropriation. Funds are appropriated to the following funds:

Overtime Expense: 001-4230-420.10-30 \$50,000

Section 4. Source of Funds.

Construction Zone Enforcement: 001-4200-334.10-12 \$50,000

Section 5. Effective Date. This ordinance shall take effect upon adoption by the Wasilla City Council.
