CITY OF WASILLA ORDINANCE SERIAL NO. 06-34

AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING WMC CHAPTER 13.20, WASILLA MUNICIPAL AIRPORT, CONCERNING THE APPOINTMENT AND AUTHORITY OF THE AIRPORT MANAGER.

- * Section 1. Classification. This ordinance is of a general and permanent nature and shall become part of the city code.
- * **Section 2. Amendment of section.** WMC 13.20.010, Definitions, is amended by amending the definition of Airport Manager as follows:

"Airport manager" means the mayor [OF THE CITY] or <u>the person that the mayor appoints from time to time as airport manager</u> [AN OFFICIAL DESIGNATED BY THE MAYOR TO MANAGE AND DIRECT ACTIVITIES AT THE AIRPORT, OR HIS OR HER DESIGNEE].

- * Section 3. Amendment of section. WMC 13.20.030, Airport Manager, is amended by amending Subsection A as follows: 13.20.030 Airport manager.
- A. <u>The</u> [AN] airport manager may exercise the powers and duties granted [HIM OR HER] by this chapter. <u>The airport manager shall enforce the provisions of this chapter and shall be vested with all powers of a peace officer of the city necessary to such enforcement duties.</u>
- * Section 4. Effective date. This ordinance shall take effect upon adoption of the Wasilla City Council.
