\* **Section 3. Appropriation.** Funds are appropriated to the following fund:



**SUMMARY STATEMENT:** This ordinance appropriates Matanuska-Susitna Borough funding for water system improvements within the subdivision that are necessary to meet city specifications. Specifically, water service lines will be replaced that have been deteriorating with aggressive water quality. This funding provides the necessary engineering for the new service lines. The Borough will fund the construction cost with federal and state grant funding they have received. The funding agreement will be amended from the current amount of \$75,000 to \$193,022 of total funding for engineering services.

**RECOMMENDED ACTION:** To adopt Ordinance Serial No. 06-41 that appropriates Matanuska-Susitna Borough funding in the amount of \$118,022 for Garden Terrace water system improvements engineering services and authorizes an amendment to the funding agreement.
