**SUMMARY STATEMENT:** This money will only be used to bus spectators within City limits to get to the Iditarod restart providing the restart is held in Wasilla. The Iditarod Trail Committee will make its decision on February 23, 2007. If the Iditarod restart is held at the Multi-Use Sports Complex, the parking lot at the MUSC cannot accommodate parking for all of the vehicles that would be coming to the MUSC. Using buses to transport the public from the local schools to the MUSC will alleviate a lot of the parking congestion. We have done this in the past and it has been very successful.
