SUMMARY STATEMENT: MTA, MEA, and ENSTAR utility contracts are required under WMC 5.08.010 in purchasing to be approved by the City Council annually. This is a result of a previous code revision (6.24.030) that inadvertently removed the Mayor's authority to purchase or make payment for utility service of government facilities. The Finance Director and City Attorney have suggested the following revision to bring back the streamlined process for purchasing and making payment of utility service:

"D. Notwithstanding subsection B of this section, the mayor is allowed to purchase or make payments for budgeted routine and ongoing contracts for public utility service without council approval; provided that the terms and conditions of service are determined by a tariff on file with a state or federal regulatory agency."

Alternatively, an Action Memorandum needs to be approved by the City Council annually for each utility service with an estimated amount for service that fiscal year.

RECOMMENDED ACTION: To adopt Ordinance Serial No. 07-18 that authorizes the Mayor to continue annual utility services for government facilities without City Council approval under certain conditions.
