AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY-07 POLICE DEPARTMENT BUDGET BY ACCEPTING AND APPROPRIATING FUNDS FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, DIVISION OF ALASKA STATE TROOPERS, ALASKA BUREAU OF ALCOHOL AND DRUG ENFORCEMENT IN THE AMOUNT OF \$1,438 FROM FEDERAL FORFEITURE.

* **Section 1. Classification.** This is a non-code ordinance.

* **Section 2. Authority.** To amend the FY-07 Police Department budget by appropriating \$1,438 from the State of Alaska, Department of Public Safety, Division of Alaska State Troopers, Alaska Bureau of Alcohol and Drug Enforcement funds to be applied to the police budget for purchase of patrol equipment.

* **Section 3. Appropriation.** Funds are appropriated to the following funds:


