AN ORDINANCE OF THE WASILLA CITY COUNCIL AMENDING THE FY 08 POLICE DEPARTMENT BUDGET BY ACCEPTING AND APPROPRIATING \$279,737 FROM THE MATANUSKA-SUSITNA BOROUGH FROM A PASS THROUGH GRANT FROM THE DEPARTMENT OF JUSTICE, 2005 COPS TECHNOLOGY GRANT TO ENHANCE COMMUNICATIONS INTEROPERABILTY AND PARTICIPATION IN THE ALASKA LAND MOBILE RADIO (ALMR) PROJECT.

Section 3. Appropriation.



SUMMARY STATEMENT: The City of Wasilla Police Department wishes to amend the FY 08 Police Department budget by \$279,737 to appropriate funds from the Matanuska-Susitna Borough from a pass through grant from the Department of Justice, 2005 COPS Technology Grant to enhance communications interoperability and participation in the Alaska Land Mobile Radio (ALMR) project. The Matanuska-Susitna Borough and the City of Wasilla have entered into a Memorandum of Agreement to set forth their mutual understanding and responsibilities and conditions related to the distribution of funds from the grant. The approval of this ordinance would designate funds for the City of Wasilla Police Department as a pass through grant to purchase certain equipment as specified in the grant and in the memorandum of agreement.

Staff Recommendation:

Amend the FY 08 Police Department budget by appropriating funds from the Matanuska- Susitna Borough from a pass through grant from the Department of Justice, 2005 COPS Technology Grant to enhance communications interoperability and participation in the Alaska Land Mobile Radio (ALMR) project in the amount of \$279,737.
