RESOLUTION NO. WR90-31

A RESOLUTION OF THE CITY COUNCIL OF WASILLA, ALASKA RECOMMENDING PRIORITIES FOR THE ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES CAPITAL PROGRAM

WHEREAS, the City of Wasilla is offered the opportunity to express its priorities for construction of state highways and public facilities; and

WHEREAS, staff has reviewed planning information, previous capital program, and made direct observation of the operation of federal aid and state highways, roads and other public facilities; and

WHEREAS, staff has recommended a list of capital construction priority projects for the 1992 fiscal year and Council has reviewed those recommendations.

NOW, THEREFORE BE IT RESOLVED that the Wasilla City Council hereby recommends the following capital construction projects be included in the Department of Transportation and Public Facilities capital improvement program:

Parks Highway

Old Matanuska Road/Hermon Road Intersection (To Construct 1991)
Urban extension, Palmer-Wasilla Highway to Crusey Street
Right turn lane at Crusey Street
Church Road Intersection
New Wasilla Airport intersection turn lanes
Eklutna to Parks, 4-lane
Glenn to Wasilla upgrade
South Wasilla Highway Bypass (Reconnaissance 1991)

Fishhook-Main-Knik Goose Bay Road

Urban rebuild, Schrock to Glendale

Old Matanuska Road

Culvert Cottonwood Creek, tie to Rainier Drive
Upgrade Matanuska Road and turn over to City

Lucus Road

Bike/pedestrian trail, Parks to Spruce
Sight distance corrections at street intersections

Church Road

Reconstruct, Parks to Spruce, pave, correct vertical lines
Airport Access Railroad Overpass South of Parks Highway

Crusey Street

Illumination, Parks to Bogard

Old Wasilla Airport

De-commission and transfer land to City - FY92

New Wasilla Airport

Construct - FY91
Pave - FY93

Maintenance Shop Site - Knik Goose Bay Road

Construct Maintenance Shop and Yard
Upgrade "Private Drive" to City standards
