RESOLUTION NO. WR95-19

A RESOLUTION OF THE WASILLA CITY COUNCIL ESTABLISHING CONDITIONS AND FEES FOR PARK AND PUBLIC FACILITY USE PURSUANT TO WMC 13.08.

WHEREAS, permits are required for certain uses of parks and sports complexes by WMC 13.08; and

WHEREAS, the Council desire to set reasonable conditions and fees to preserve and maintain the park facilities, control costs and protect the safety and quiet enjoyment of the general public and neighboring property.

NOW THEREFORE BE IT RESOLVED, that permits for alcohol dispensing, special uses, animals, motor vehicles, firearms and fireworks may be issued by the Mayor or his designee and will require the permitee to meet the following standards:

Application will be made at least two weeks in advance;

Litter and waste created by the activities of the permittee will be collected and disposed of by the permittee;

Sanitary and solid waste, or facility maintenance activities needed for the activity which are over and above those provided at the location will be provided by the permittee;

Permittee shall control activity to avoid damage to City facilities;

Damage to City facilities resulting from activity shall be repaired by permittee;

The need for traffic control will be reviewed by the Chief of Police and when deemed necessary shall be provided by the permittee;

Activities which are likely to produce noise disturbing the peace of the surrounding area are to be limited as to time and duration in order to minimize negative impacts;

Permit applicant shall provide event liability insurance in the amount of \$1,000,000 with the City named as an additional named insured when the event includes or incorporates significant commercial activities such as sales of products, services or entertainment and/or entrance or participation fees. The Mayor or his/her designee is authorized to make the determination as to when significant commercial activities exist and thereby requiring insurance.

A fee shall be charged for issuance of the permit which will not exceed the actual costs of extraordinary City efforts plus \$100. The Mayor may waive fees for low-impact negligible cost events sponsored by community, not-for-profit or charitable organizations;

A deposit to guarantee performance may be required.

A permit application may be rejected when the proposed activity exceeds the safe capacity of the facility or would likely cause damage to the facility or would likely disturb the peace.
