RESOLUTION NO. WR96-44

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WASILLA, ALASKA DIRECTING THAT A SURVEY BE TAKEN OF THE BENEFITED PROPERTY OWNERS FOR THE PURPOSE OF INITIATING ROAD PAVING WITHIN THE CITY OF WASILLA AND REPEALING RESOLUTION NO. WR95-30.

VAUNDA AVENUE PAVING SURVEY

WHEREAS, property owners have requested that road paving improvements be made; and

WHEREAS, costs of the requested improvements and paving of Vaunda Avenue have been obtained; and

WHEREAS, the City Council must receive approval of the property owners who will bear the majority of the assessable project costs before proceeding with the project;

NOW THEREFORE BE IT RESOLVED:

1. That the City Council hereby directs that a survey be taken among owners of benefited property within the area on the attached map and referred to as Vaunda Avenue Paving District described below, located within Section 5, Township 17 North, Range 1 West, Seward Meridian as follows:

Lots 6 - 10, Block 2, Upper Wasilla Heights Subdivision, Lots 1 - 5, Block 3, Upper Wasilla Heights Subdivision.

- 2. The City of Wasilla will pay 67% of the assessable project costs. The remaining costs are estimated assessments to be divided among all benefited lot owners in the district on a per lot basis.
- 3. Interest rate to be the rate charged by our lender plus 1% for reserves.
- 4. The assessments will be payable over a 10 year schedule.

5. That a public hearing will be held in the City Council Chambers, 290 E. Herning Avenue, 7:00 p.m., November 25, 1996 on the necessity of the paving project and to hear any protests. Protests returned after the close of the public hearing will not be considered.

BE IT FURTHER RESOLVED, that Resolution No. WR95-30 is hereby repealed.
