**RESOLUTION NO. WR97-04**

A RESOLUTION OF THE CITY OF WASILLA, ALASKA, CLARIFYING THE NUMBERING OF PAVING ASSESSMENT DISTRICTS 94P4 AND 95P1.

WHEREAS, the Wild Adventure Paving LID was initially formed pursuant to Resolution No. WR94-64 which assigned 94P4 as the Paving Assessment District number for the paving local improvement district; and

WHEREAS, upon a re-evaluation of the probable cost, it was determined that the formation procedure should be commenced anew and that prior resolutions relating to the district should be repealed; and

WHEREAS, said prior resolutions were repealed, and after written notice mailed to all affected property owners setting out the revised estimated assessment amounts, the City Council adopted Resolution No. WR95-13 creating the Wilder Adventure Paving LID which was assigned 95P1 as the Paving Assessment District number; and

WHEREAS, the lots, and the type and scope of paving improvements proposed for the original PAD No. 94P4 (Wild Adventure Paving LID) were the same as those in PAD No. 95P1 (the Wilder Adventure Paving LID); and

WHEREAS, subsequent to the adoption of Resolution No. WR95-13 establishing 95P1, this paving LID was referred to as the Wild Adventure District 94P4; and

WHEREAS, all property owners within the subsequently formed district received mailed notice of the actual assessment proposed to be levied against the benefited property within the district, notwithstanding the district's being identified as the Wild Adventure Paving Assessment District No. 94P4; and

WHEREAS, the confirmed assessment roll for the LID recorded at book 876, pages 771-775 of the Palmer Recording District identifies the property within the LID as being in the Wild Adventure Paving LID 94P4;


NOW THEREFORE, BE IT RESOLVED by the Wasilla City Council that all references to the Wild Adventure Paving Assessment District No. 94P4 in Resolution No. WR96-56 and in attachments thereto are amended to read 95P1, and references in said resolution to Resolution No. WR94-64 are amended to read Resolution No. WR95-13. The City Council hereby declares that it was and is the intent of the City that:

1. PAD 94P4 and 95P1 be the same with respect to the property included within their boundaries, the type and scope of paving improvements to be made and in all other respects except for the cost and assessment amount; and

2. The assessment district liens established pursuant to Resolution Nos. 95-13 and 96-56 against the benefited property in the district as reflected in the assessment roll attached to and approved under Resolution No. WR96-56 are effective notwithstanding a reference on said roll to LID 94P4; and


3. Any reference to LID or PAD 94P4 subsequent to the adoption of Resolution No. WR95-13 on March 29, 1995 shall be read as and shall be a reference to LID or PAD 95P1.

I certify that a resolution in substantially the above form was passed by a majority of those voting at a duly called and conducted meeting of the governing body of the City of Wasilla this 27<sup>th</sup> day of January, 1997.
